## Regulations, Red Tape, and Resident Care

### F-Tag Review Series: Comprehensive review of Regulations and Interpretive Guidance for top F-Tags

During this year long series, we will focus on a review of the top deficiencies cited nationally with the new Long Term Care Survey Process (LTCSP). Each session will focus on top-cited F-Tag with a review of the regulation and an analysis of the associated Interpretive Guidance. A review of survey procedures, such as associated Critical Element Pathways and/or Survey-or Probes used to guide the investigative process will be discussed. Actual citation examples will be shared and discussed. Tools to assist the facility interdisciplinary team in monitoring compliance and incorporating performance improvement activities into the facility QAPI processes will also be discussed.

December—Bowel/Bladder Incontinence, Catheters, UTIs F690
